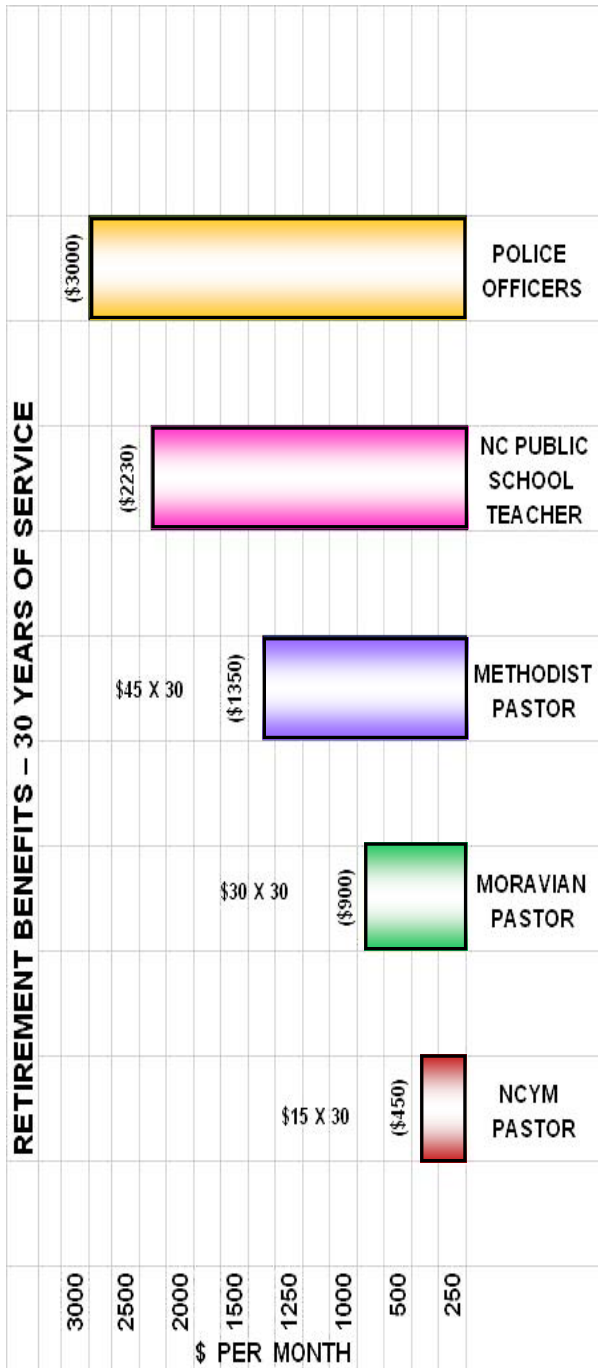

Thank you for your support in 2009 with the special Sunday offering. Again this year we will have a special Sunday offering in October which is also Pastor Appreciation month. What better way to show our love and support for our ministers.

Goal: \$100,000



These three steps are necessary to enhance and strengthen the Share the Blessing II campaign:

1. **Annual Giving** - Establish an annual Share the Blessing II offering in the month of October to coincide with Pastor Appreciation month.
2. **Capital Campaign**- Conduct a QUIET CAMPAIGN. This would be directed at a select group of people throughout North Carolina Yearly Meeting who are capable of providing leadership gifts. The goals of this phase are:
 - A. to raise \$2 million
 - B. to enhance and increase the endowment already established to provide annual income for the retirement benefits.
3. **Planned Giving**- Put into place a visible marketing plan to educate and promote the idea of charitable estate giving. This would be the "Wills Emphasis" phase of the Share the Blessing II campaign. The focus will be to inform Friends about giving through wills, trusts, estate, land, etc. The recommendation is to promote this in April of each year.

Share the Blessing II will be visible at least four times per year through annual giving, wills emphasis, Mid Year Gathering and Yearly Meeting sessions.
